



INITIAL CONSULTATION AGREEMENT

This is to confirm that I, _____ am obliged to pay a fee of \$100 Canadian Dollars plus HST or its equivalent, if paying in other currency / denomination, for initial consultation with the Regulated Consultant "Dastur Immigration Services Inc." for up to 30 minutes, If I retain the consultant (within 2 week of the initial consultation) by signing a Legal Fee Agreement AND pay the Regulated Consultant's services fee as agreed upon, the initial consultation fee will be credited towards the total service fee. A fee for each service option, based on the facts presented, will be quoted during the consultation meeting, provided that all relevant documents have been presented before or during the meeting. Payment terms will be discussed during the consultation and will be detailed in the retainer agreement.

The information provided to the consultant in the Initial Consultation Form, and during the consultation, is for the purpose of obtaining a consultation and is not intended for the purpose of establishing a consultant client relationship until an individual seeking representation has executed a written legal services agreement entering such a relationship with the consultant.

Initial Consultations, which are scheduled by the assistant staff or regulated consultant, can be provided by telephone, Zoom / Skype Audio-Video Call, or any other Audio or Video or both, email and as well as in person.

The purpose of the consultation is to provide the consultant with sufficient information to allow for a full analysis and comprehensive advice on immigration options & streams, including estimated time frames, legal fees, and costs.

These terms and conditions shall be governed by the laws in effect in the Province of Ontario, Canada.

Please be advised that the consultant is a member in good standing of The College of Immigration and Citizenship Consultants (formerly known as ICCRC), having Membership #: R709396 and as such, is bound by its By-laws, Code of Professional Ethics, and associated Regulations.
